- There is a workshop tomorrow morning 11:00 am to 12:00 pm. School Boards is putting something together called A New Board Member Orientation, it will be online. NJ School Boards workshops are still online for one month.
- Bergen County meeting emphasized on new Board member training/fundamentals.

- Ms. Ruckett asked about the students here that are in 8th grade and now they have learned that there will be a PTO in the Middle school. Parents asked which PTO they should go to?
- Mr. Kennedy responded they should go to the PTO in their building.

The Spanish teacher is out on maternity leave and that's why we can't pivot to a new language because will be coming back soon. We are doing the best that we can to provide a course to them, knowing that we will get our teacher back within a month.
- Idalisa Demetriades, 43 Pine Street, Bogota, NJ, thanked Mr. Kennedy, Chief of Bogota PD and Steen Principal for the morning drop off, it has been going smoothly.

 Aftercare gets very dark when we pick up the kids after 5:00 pm and can we put some lights?
- Mr. Kennedy responded we will double check that, maybe it is on a timer and not recognizing the time change, but there are lights there. We will check on that tomorrow.
